1 in 200 Americans receive a marrow or blood stem cell transplant in their lifetime.

Every **3 minutes** someone in the US is diagnosed with blood cancer.

1 in 6 patients for whom Gift of Life conducts donor searches are children.

70% of patients do not have a related match and must search the registry.

1 in 200 donors ages 18 to 30 will be called as a match for a patient in need.

Every **\$2K** will facilitate one transplant over time.

1 in 5 donor matches are selected for a transplant.

80% of donors give peripheral blood stem cells from their arm rather than bone marrow.

SPONSORSHIP TERMS AND CONDITIONS

The Sponsor hereby agrees with Gift of Life Marrow Registry (hereafter "Management") as follows:

1. Sponsor will complete full set up of Sponsor's booth by the time stated on the exhibitor instructions sent prior to the event.
2. Sponsor acknowledges and agrees that setup times are not negotiable. Sponsors will not be admitted to the event before published times.
3. Sponsor agrees to provide booth staffing for Sponsor's booth at all times.
4. Sponsor agrees space assignments may be changed by Management.
5. Sponsor agrees that no refunds will be made to an exhibitor who fails to occupy their designated booth space.
6. Sponsor agrees not to sublet space, exhibit any merchandise, or distribute any food or beverages other than that specified on the exhibitor sign-up form without written permission from Management.
7. All vendors sampling and distributing, of food items meet applicable Health Department requirements. Management will provide the necessary forms to fill out and Sponsor must comply by the deadline assigned.
8. Sponsor agrees that displays will not visually or physically disturb aisles or adjacent exhibitors.
9. Sponsor agrees not to make any undue noise or odor, use bright or hazardous lights, cause damage to expo space or booth equipment, or act in any manner deemed inappropriate by Management.
10. Sponsor agrees that Management reserves the right to reject, restrict, limit, or remove any exhibit.
11. Sponsor agrees to conform to all City Codes, City Fire Department Rules and Regulations, and other applicable local and state laws. Any violation of these may result in forfeiture of booth space without refund.
12. Sponsor agrees to carry the necessary workman's comprehensive general liability insurance and any other insurance that may be required. Management may require Sponsor to present a certificate of insurance.
13. Sponsor agrees that it shall be liable for all damages that s/he may cause in connection with his/her exhibit and which result from any act of omission of Sponsor. Furthermore, Sponsor agrees to defend, indemnify, and hold harmless Gift of Life Marrow Registry, its owners, officers, directors, employees, agents, assigns and insurers from any damages or charges resulting from Sponsor's use of the property. Sponsor's liability shall include all losses, costs, damages or expenses arising from, out of, or by reason of any accident or bodily injury or other occurrences to any property, person or persons.
14. Sponsor agrees to assume all responsibility for loss, theft, or destruction of goods and for all personal injuries to himself/herself, his/her employees, agents, representatives, or visitors, and will hold harmless Gift of Life Marrow Registry from any and all liability in connection with any and all of the above.
15. Sponsor understands that Gift of Life does not maintain insurance covering Sponsor's property or lost revenue and it is the sole responsibility of Sponsor to obtain such insurance.
16. Sponsor acknowledges and agrees that Sponsor forfeits their booth space, without refund, if all conditions of payment, signed terms and conditions, and other forms as necessary apply, are not met by the appropriate deadlines.
17. Sponsor understands and agrees that his/her photograph or video images and recordings of his/her voice may be made and/or used in memorializing, promoting, or advertising the event or subsequent similar events, in any form, and that no compensation will be due to them in that regard. Sponsor irrevocably grants Management the exclusive right and authority to copyright, use, and publish such images or recordings for these purposes. This right and authority shall belong to the Management at all times and shall survive the termination of this Agreement.
